#### **INTRODUCTION**

The Child Abuse Prevention Council of Contra Costa County (CAPC) is a nonprofit, tax exempt 501(c) 3 organization. CAPC 's mission is to prevent child abuse and neglect in Contra Costa by raising community awareness, influencing public policy, educating the community and providing resources and support programs to families.
